**Do not wait until you are ready to brand before submitting application. Brands must be registered with this office to be a valid Wyoming brand. Allow 2 to 5 days for application processing.**

### **FEES**

Fees must be submitted at the time of application, we accept cash, check, money orders, Visa, Master card, and Discover. Credit card payments can be made by calling the office.

- All abandoned brands are \$330.00 regardless of how many species.
- In the event a brand is not recorded you may request a refund, a percentage of the application fee shall be refunded.

### **LEGAL RECORDING ON APPLICATION**

If the brand is to be re-recorded in more than one name, please indicate if it is:

- TENANTS IN COMMON (without Rights of Survivorship)
- HUSBAND AND WIFE (with Rights of Survivorship)
- JOINT TENANCY (with Rights of Survivorship)
- PARTNERSHIP (list all partners)
- CORPORATION (list contact person)
- TRUSTS (list all trustee(s))

The use of "AND" or "OR" between names of brand owners will determine the endorsement requirements for a check in regards to the sale of livestock. The use of "AND" or "OR" does not change the ownership rights on the brand.

### **RECORDING BRANDS TO MINORS**

A brand can be recorded in the name of a minor, however if the brand is to be transferred to a new owner, a notarized signature of the minor's legal guardian is required.

### **BRAND IMAGE**

Please submit one (1) choice. DOTS, SINGLE CHARCTERS OR SYMBOLS OR BRANDS THAT ARE RECORDED ON TWO (2) LOCATIONS FOR CATTLE WILL NOT BE REISSUED. When brand research and approval has been completed we will reissue the brand to you. If the brand you requested is not available, we will call you for another choice.

### **BRAND LOCATION**

- Branding locations are issued "as is" from the previous registration of the brand; no alterations are allowed.
- **EARMARKS** are optional but should be used if recorded with brand.

### **BRAND RENEWAL**

All new brands will fall due for renewal in the cycle originally issued with the brand. For more information, please contact this office.

### **TRANSFER OF BRANDS**

Brands may be transferred using a *Bill of Sale/Transfer Form* available through this office or website. Please contact this office for further information on the transfer/ sale of a brand.
